Hi Heather-

Given the very mixed nature of the 4A/4B areas (grass, paving, gravel) that has been described in the instructions, it seems difficult for us to judge what goals would be met to fulfill the condition. Is the test for checking this off the list basically going to be "make it look like the photos from a particular date?"

Maybe you can help me understand this a bit better- will damaged gravel or paving be replaced in kind, or replaced with grass? Does the future of this site involve additional uses that will need the pavement (however damaged) to remain? In areas that are bare dirt or mud during/after construction activities, will grass be planted in non-paved areas to reduce any negative visual impacts? As always, our concerns are for temporary or permanent effects on nearby historic properties.

Dear Dr. Snyder and Ms. Adkins:

As requested by your office on 8 February 2017 and considering feedback provided by email from your office on 22 February 2017, this letter provides additional information regarding the Rover Pipeline LLC (Rover) Project's (Project) proposed use of the Spread 1 Main Contractor Yard Options 4A and 4B in Dennison, Ohio.

The northern parcel of the proposed yard includes a lot covered by compacted gravel and a grassy area that has been disturbed by heavy machinery, and the southern parcel is covered by some grass, with concrete pads and walkways. Per Rover's lease agreement with the landowner, the contractor will restore this property to the same or better condition than it is now. This will include the following:

- Restoration of disturbed vegetated areas by returning them to original grade and then mulching and seeding as needed, unless the landowner requests that areas remain graveled
- Restoration of the existing gravel area to its original state by smoothing or adding additional gravel as necessary
- Use of the contractor yard will not damage existing concrete pads and walkways
- No permanent structures will be built within the contractor yard for the project
